A. COURSE DESCRIPTION AND OBJECTIVES

A1. COURSE DESCRIPTION

The European Union is the most successful experiment in international cooperation in modern times, but its 500 million citizens (and non-Europeans) often see it as remote and unnecessarily complex. This is a result of the difficulty in classifying what the EU is. By combining features of a state with those of an intergovernmental organization, European integration has stretched our conceptual understanding of international relations and comparative politics. This course introduces the main conceptual approaches to understanding what the European Union is, how it works, and why it works when similar attempts at high-level international cooperation have failed. It then explores the major challenges facing the European Union with a view towards Europe's future.

The objective of this course is to gain an understanding of the development of the European Union and the vital role it plays in the world today. It traces the early beginnings and purpose of the European Community following the 2nd World War. The course covers major EU organizations and institutions, the commerce it promotes among member states, and the vital role it plays as world's largest and most powerful economic trading group.

B. CRITERIA FOR ASSESMENT

B1. PERCENTAGES

Midterm 30%

Final Exam 40%

Oral and Written presentation 30%.

B2. EXAMS

Exams will be divided into two main parts. One part will be multiple choice and the other will consist of questions to be developed by the student. In the final exam, as well as the above, the student will have a case study where questions related to knowledge acquired during the course must be answered.

The exams consist of two parts, test questions and to develop some current affairs, which will have been discussed in class formerly.

B3. ORAL AND WRITTEN PRESENTATION

These will deal with two countries from the European Union. The student is going to create a presentation for two members of the EU, and the oral presentation should last approximately ten minutes per country.

Attention will be focused mainly on economic issues and relations with other members of the European Union, providing current data for each country.

The study will include the cultural environment, and research of the political, social and economic challenges continuing to face European integration

For the written presentation, students will have complete freedom with regard to structure and development, and the originality and quality of the content will be taken into account for purposes of evaluation.

The presentations are to be developed between the first and second exams, the oral presentation will take place between the second and final exam and the written presentation will be handed in at the student's oral presentation.
